- 2. Each OP Unit is redeemable at the election of the holder for cash equal to the then fair market value of one share of Issuer common stock, or at the Issuer's election, one share of Issuer's common stock, subject to adjustment as set forth in the partnership agreement. OP Units do not expire.
- 3. 100% of the reporting person's PIUs granted on June 5, 2023 will vest on the date of the Company's 2024 Annual Meeting of Shareholders, subject to continued service.
- $4.\ Includes\ 6,400\ vested\ PIUs\ which\ can\ be\ converted\ to\ OP\ units\ if\ certain\ tax-related\ conditions\ are\ met.$
- $5.\ 100\%\ of\ the\ reporting\ person's\ PIUs\ granted\ on\ June\ 3,\ 2022\ vested\ and\ converted\ into\ OP\ Units\ on\ June\ 5,\ 2023.$
